Director Identification Number (DIN)

The Commonwealth Government passed the Registers Act 2019 on the 22 June 2020. The Act stipulates that all charities with the Australian Charities and Not-for-Profits Commission, including registered Australian bodies such as an incorporated association registered under a State Act, must be registered. This includes incorporated associations established under Australian state or territory legislation or any organisation that is a legal entity and runs using a business structure. There is now a staged process in place to implement the law, beginning on the 31 October 2021.

On further investigation via the Department of Mines, Industry Regulation and Safety, where associations are incorporated in WA, the following advice was received.

It is my understanding that the officers and committee members of state based incorporated associations will not be required to obtain director IDs <u>unless</u> the incorporated association is a registered Australian body that has an Australian Registered Body Number (ARBN). Incorporated Associations that are registerable Australian Bodies will need to obtain the director IDs. - Rebecca White, Business and Systems Improvement Coordinator
